An affidavit of support or a letter of support does not act as proof that the marriage is legit. Documents like common ownership of an apartment or estates, joint lease of an apartment, financial records proving joint ownership, details of the children you have had together have to be presented to the immigration officers in support of your marriage. You can file the petition alone and your petition will be considered by the USCIS in such scenarios. This will not provide any further information for the immigration office. Affidavit of bona fide marriage does not have a strictly binding form. If the couple was married with the best of intentions, but later the marriage was dissolved, the resident must file I-751 with a waiver regardless of whether there was a divorce or the death of a spouse. U.S. Citizenship and Immigration Services (USCIS) requires Form I-751 (you can find instructions for it here), and as support for this form, you can provide an immigration letter of support. You will need to provide other strong evidence to prove that your marriage is a legitimate one. Notarization is also not required but recommended. Immigration Services can also call the author of the letter for an interview, so they should be extremely honest in their testimony. One should not be afraid to include "trivial" things like describing a couple going to the local Sunday market to shop. The various important segments of an affidavit of support letter or a letter of support. As included in the sample letter below, the different segments that the affidavit letter of support should contain are as follows: The name of the person who is writing the letter.The address of the person writing the letter.The date when the letter is being written.USCIS address.The subject line states who this letter concerns.The body of the letter: This should contain your relationship with the individual(s) you are writing in support of, how long have you known each other, details about how you have met the couple, how they are as an individual, mention if you know something about their family, some facts about the marriage that you know. Close the letter with your name, date of birth, and place of birth. It is critical to remember that these letters are not proof of good faith marriage. You can apply for the i-751 alone not needing to meet the regular requirements. What does i-864 form entail and what information does the i-864 form provide to immigration officers about the applicant?
